

Refund of the JLU Gießen Semester Ticket Contribution

The most important informations at a glance

A refund of the **Germany Semester Ticket contribution (Deutschlandsemesterticket)** is only possible in the cases specified in the refund regulations.

Before submitting your application, please make sure that you meet the relevant requirements and submit all required supporting documents completely and within the applicable deadline.

Application Deadlines

Antrag 1 – General Grounds for Refund

Frist: 09. November 2026

- Auslandsstudium / Study abroad
- Studienbedingtes Auslandspraktikum / Study-related internship abroad
- Schwerbehinderung / Severe Disability
- Urlaubssemester / Leave of Absence
- Doppelimmatrikulation / Double Enrollment at two universities
- Doctoral studies with a study-related stay abroad
- Final degree phase with primary residence abroad for study-related reasons

Antrag 2 – Medical Reasons

Frist: 10. Mai 2027

- Inpatient medical treatment
- Outpatient medical treatment
- Chronic Illness

Please note: Refunds are granted on a pro-rata basis according to the duration of the medically certified restriction. A full refund is only possible if the restriction covers the entire semester for which the refund is requested.

Antrag 3 – LandesTicket Hessen

Frist: 09. November 2026

For students who hold a **LandesTicket Hessen** that is valid for at least three months during the relevant semester.

Important informations regarding Ticket Activation

A refund of the Germany Semester Ticket contribution is generally **not possible** if the Germany Semester Ticket has already been activated.

If you intend to apply for a refund, **do not open the activation link**. Opening the activation link automatically activates your Germany Semester Ticket.

How to submit your Application

1. Select the appropriate Application Form.
2. Attach all required supporting documents.
3. Combine the completed application form and all supporting documents into **one single PDF-File**.
4. Send the PDF by email before the deadline to: semesterticket@asta-giessen.de

After your Refund has been approved

- Your Deutschlandsemesterticket for the relevant semester will be deactivated.
- Your travel entitlement for that semester will expire.
- The ticket cannot be reactivated at a later date.

Praktische Hinweise

- The JLU student ID Card is **not** a valid travel ticket.
- The student ID card does not need to be submitted with your application.
- Incomplete applications can only be processed once all required documents have been received.
- Please submit your application as early as possible.
